**NOTICE OF DISMISSAL**

Case 7:09-CV-050-0

Case 7:11-CV-00031-O

Richard Roper, the Receiver, moves the Court to dismiss this case against the below defendants, and in support of this motion shows:

On March 1, 2011, the Receiver filed his Complaint against certain winning investors. [Dkt. No. 1]. In the underlying receivership action, *SEC v. Millennium Bank et al*, No. 7:09-CV-050-O, currently pending in the United States District Court for the Northern District of Texas, Wichita Falls Division, the Receiver requested, and the Court entered, an order establishing procedures governing the recovery of assets in third-party litigation. [Dkt. Nos. 149, 156] Under this Order, the Receiver was permitted to serve the Winning Investors by various methods, including certified mail, return receipt requested. [Dkt. No. 149, ¶ 9]. The Receiver did serve all Winning Investors against whom he seeks dismissal, either by certified mail, return receipt requested, or by personal service, with several exceptions.<sup>1</sup> However, those Winning Investors listed below for whom the Receiver cannot confirm service did receive notice of the lawsuit and contacted the Receiver to resolve the claims against them (which were successfully compromised).

The below defendants have not served an answer<sup>2</sup> or motion for summary judgment in this case. The disputes between the Receiver and following defendants that are the subject of this action have been compromised and settled.

<sup>2</sup> Defendants Jaclyn Blecher and Marie Pranschke filed answers in this case, but resolved their claims with the Receiver after so doing. The Receiver agreed to dismiss the claims against them.
